The net tangible asset backing of Argo Investments Limited shares at 30 June, 2010 was \$5.82 per share.

The Company is a long-term investor and does not intend disposing of its long-term investment portfolio. However, under current accounting standards the Company is required to provide for tax that may arise should the portfolio be disposed of on 30 June, 2010. After deducting this theoretical provision, the above figure would be \$5.32 per share.
